### Nutrition Services Update

- The focus is to get students applications in for free and reduced meals. 62% have qualified for free or reduce lunch so far. We're reaching out to high balance families to urge them to sign up.
- Holiday meal is planned for the last day before break.
- The third vending machine at RMS went live and has sushi in it.

# Safe Routes to Schools Update

- RPS and Richfield Public Works will soon kick off a demonstration project to test a walking route near Centennial Elementary.
- We have installed about half of the new bicycle parking from the district's 2022 Boost Grant. Concrete installation and remaining bike racks will be installed in the spring.
- We applied for another Boost Grant to purchase a fleet of balance bikes (Strider is the most popular brand) for use in PreK, Kinder, and 1st Grade classes.
- We applied for a No Child Left Inside Grant to purchase a small fleet of cruiser bikes for all-year use at RCEP.
- Get ready for Winter Walking Day on February 22!

- The committee is working on having a chef come on-site for healthy meal options.

### **HEALTH & SAFETY UPDATE**

- Indoor Air Quality Staff Survey Survey will be sent out in January by Dan Kretsinger for anyone to fill out about the air quality in their room/space. While the technician is doing the IAQ walkthrough, they could look for certain concerns that are identified in the survey.
- Indoor Air Quality Walkthrough (2/1-2/3, 2/9-2/10) An IEA technician will be out to all buildings to monitor the air in every room and office. The monitoring device will read Temp, Humidity, CO, CO2. The technician will look for any moisture or odor concerns.
- EHS Tasks: Science Lab Inspections, Eyewash Inspections, Fume Hood Inspections (11/8 & 11/23) These inspections occurred last month. Once IEA and Dan have come up with a corrective action list for the items, IEA will send out to the CHOS at the HS and MS.
- Hennepin County Hazardous Waste Report Due 12/15 Submitted for review to Hennepin County. RHS and Bus Garage share the same license and is a VSQG. This report is required for any business to maintain disposal of hazardous waste.
